Oregon law (ORS 336.201) defines three levels of severity related to required nursing services: <ol style="list-style-type: none"> 1. Medically Complex: Are students who may have an unstable health condition and who may require daily professional nursing services. 2. Medically Fragile: Are students who may have a life-threatening health condition and who may require immediate professional nursing services. 3. Nursing-Dependent: Are students who have an unstable or life-threatening health condition and who require daily, direct, and continuous professional nursing services. 	<p>Instruction would be based on each child’s needs. The teachers and parents would work together to build their own models.</p> <p>Students who receive services such as reading tutors will work with admin and staff to formulate a plan/schedule.</p> <p>Visitors/Volunteers will not be allowed to onsite at this time. Adults onsite are limited to only essential personnel.</p> <p>To this date MCH doesn’t have any students who require additional nursing services. Additionally, we’re too small of a school to employ a nurse.</p>

<p>x Staff and school administrators, in partnership with school nurses, or other school health providers, should work with interdisciplinary teams to address individual student needs. The school registered nurse (RN) is responsible for nursing care provided to individual students as outlined in ODE guidance and state law:</p> <ul style="list-style-type: none"> • Communicate with parents and health care providers to determine return to school status and current needs of the student. • Coordinate and update other health services the student may be receiving in addition to nursing services. 1c. PHYSICAL DISTANCING

<p>x Establish a minimum of 35 square feet per person when determining room capacity. Calculate only with usable classroom space, understanding that desks and room set-up will require use of all space in the calculation. This also applies for professional development and staff gatherings.</p> <p>x Support physical distancing in all daily activities and instruction, maintaining six feet between individuals to the maximum extent possible.</p> <p>x Minimize time standing in lines and take steps to ensure that six feet of distance between students is maintained, including marking spacing on floor, one-way traffic flow in constrained spaces, etc.</p>	<p>2 Mixed-Age Classrooms (3-6 years)</p> <p>Tanager Meadow 965 sq ft/35 = not to exceed 26 people including staff and children</p> <p>Chickadee Grove 980 sq ft/35 = not to exceed 27 people including staff and children</p> <p>Each classroom has their own entrance/exit and bathrooms.</p> <p>Each child will have an assigned seat within the classroom and their own cubbies for their personal items.</p>

<ul style="list-style-type: none"> x Schedule modifications to limit the number of students in the building (e.g., rotating groups by days or location, staggered schedules to avoid hallway crowding and gathering). x Plan for students who will need additional support in learning how to maintain physical distancing requirements. Provide instruction; don't employ punitive discipline. x Staff should maintain physical distancing during all staff meetings and conferences, or consider remote web-based meetings. 	<p>Children will eat snacks and lunch in their own classrooms at their assigned seats.</p> <p>MCH has scheduled outside times for each classroom. Each classroom has their own outdoor equipment.</p> <p>Staff will demonstrate and model for children appropriate social distancing practices when inside and outside of school.</p> <p>All staff meetings and parent conferences will be conducted virtually or over the phone.</p>

1d. COHORTING

<ul style="list-style-type: none"> x Where feasible, establish stable cohorts: groups should be no larger than can be accommodated by the space available to provide 35 square feet per person, including staff. <ul style="list-style-type: none"> • The smaller the cohort, the less risk of spreading disease. As cohort groups increase in size, the risk of spreading disease increases. x Students cannot be part of any single cohort, or part of multiple cohorts that exceed a total of 100 people within the educational week. Schools should plan to limit cohort sizes to allow for efficient contact-tracing and minimal risk for exposure. x Each school must have a system for daily logs to ensure contact tracing among the cohort (see section 1a of the Ready Schools, Safe Learners guidance). x Minimize interaction between students in different stable cohorts (e.g., access to restrooms, activities, common areas). 1e. PUBLIC HEALTH COMMUNICATION

OHA/ODE Requirements	Hybrid/Onsite Plan
<ul style="list-style-type: none"> x Communicate to staff at the start of On-Site instruction and at periodic intervals explaining infection control measures that are being implemented to prevent spread of disease. x Develop protocols for communicating with students, families and staff who have come into close contact with a confirmed case. <ul style="list-style-type: none"> • The definition of exposure is being within 6 feet of a COVID-19 case for 15 minutes (or longer). x Develop protocols for communicating immediately with staff, families, and the community when a new case(s) of COVID-19 is diagnosed in students or staff members, including a description of how the school or district is responding. 	<p>Communication outlining the instructional model, the rationale and vision behind it, and specific infection control measures has been shared with all families and staff.</p> <p>Communication that outlines our instructional model, the rationale and vision behind it, and specific infection control measures will be shared with all staff families through print and electronically when available.</p> <p>Additional communication regarding protocols will be shared with families bi-monthly or as updated information is available throughout the school year. These communications will also be shared on our website.</p>

<p>x Provide all information in languages and formats accessible to the school community.</p>	<p>We have a template letter including how MCH is responding to send when there is a confirmed case among students or staff.</p> <p>Additionally, if there is a confirmed case among students or staff, we have a letter prepared to send out to our community which outlines how the school will respond.</p>

1f. ENTRY AND SCREENING

OHA/ODE Requirements	Hybrid/Onsite Plan
<p>x Direct students and staff to stay home if they, or anyone in their homes or community living spaces, have COVID-19 symptoms, or if anyone in their home or community living spaces has COVID-19. COVID-19 symptoms are as follows:</p> <ul style="list-style-type: none"> • Primary symptoms of concern: cough, fever (<i>temperature</i> greater than 100.4°F) or chills, shortness of breath, or difficulty breathing. • Note that muscle pain, headache, sore throat, new loss of taste or smell, diarrhea, nausea, vomiting, nasal congestion, and runny nose are also symptoms often associated with COVID-19. More information about COVID-19 symptoms is available from CDC. • In addition to COVID-19 symptoms, students should be excluded from school for signs of other infectious diseases, per existing school policy and protocols. See pages 9-12 of OHA/ODE Communicable Disease Guidance. • Emergency signs that require immediate medical attention: <ul style="list-style-type: none"> ○ Trouble breathing ○ Persistent pain or pressure in the chest ○ New confusion or inability to awaken ○ Bluish lips or face (lighter skin); greyish lips or face (darker skin) ○ Other severe symptoms <p>x Screen all students and staff for symptoms on entry to bus/school every day. This can be done visually and/or with confirmation from a parent/caregiver/guardian. Staff members can self-screen and attest to their own health.</p> <ul style="list-style-type: none"> • Anyone displaying or reporting the primary symptoms of concern must be isolated (see section 1i of the Ready Schools, Safe Learners guidance) and sent home as soon as possible. See table "Planning for COVID-19 Scenarios in Schools." • Additional guidance for nurses and health staff. <p>x Follow LPHA advice on restricting from school any student or staff known to have been exposed (e.g., by a household member) to COVID-19. See table "Planning for COVID-19 Scenarios in Schools."</p> <p>x Staff or students with a chronic or baseline cough that has worsened or is not well-controlled with medication should be excluded from school. Do not exclude staff or students who have other symptoms that are chronic or baseline symptoms (e.g., asthma, allergies, etc.) from school.</p> <p>x Hand hygiene on entry to school every day: wash with soap and water for 20 seconds or use an alcohol-based hand sanitizer with 60-95% alcohol.</p>	<p>Students will be screened by staff members before entering their classrooms. Each classroom has a separate entrance/exit. Parents will be involved in the screening process so they may take their child home if there are any symptoms. There is a place on the sign-in/out form to indicate the screening was done before entering the building. Children will go in and directly wash hands.</p> <p>Each staff member washes their hands/uses hand sanitizer immediately after entering the building. Takes their temperature and records it along with the date and time. When they sign in they are affirming that they are symptom free and that they have had no contact with anyone with a confirmed case of COVID-19.</p> <p>Reminders to parents to report actual symptoms when calling students "in sick" as part of communicable disease surveillance. Any student or staff known to have been exposed (e.g., by a household member) to COVID-19 shall not be allowed on campus until the passage of 14 calendar days after exposure and until symptoms (e.g., fever, cough, shortness of breath, sore throat, headache) are improving.</p> <p>Do not exclude staff or students who have a cough that is not a new onset or worsening cough (e.g., asthma, allergies, etc.) from school.</p> <p>Parents/guardians can provide information regarding existing conditions that cause coughing to be utilized for the purpose of screening, as previously existing coughs that are not worsening are not considered symptomatic of COVID-19.</p>

1g. VISITORS/VOLUNTEERS

OHA/ODE Requirements	Hybrid/Onsite Plan
<ul style="list-style-type: none"> x Restrict non-essential visitors/volunteers. <ul style="list-style-type: none"> • Examples of essential visitors include: DHS Child Protective Services, Law Enforcement, etc. • Examples of non-essential visitors/volunteers include: Parent Teacher Association (PTA), classroom volunteers, etc. x Screen all visitors/volunteers for symptoms upon every entry. Restrict from school property any visitor known to have been exposed to COVID-19. See table "Planning for COVID-19 Scenarios in Schools." x Visitors/volunteers must wash or sanitize their hands upon entry and exit. x Visitors/volunteers must maintain six-foot distancing, wear face coverings, and adhere to all other provisions of this guidance. 	<p>Visitors/Volunteers will be unable to work in schools, or complete other volunteer activities that require in person interaction, at this time. Adults in schools are limited to essential personnel only.</p> <p>Essential visitors must wear a face covering, wash hands/use hand sanitizer upon entering the building, sign in and record temperature.</p> <p>A staff member will screen all essential visitors for symptoms upon entry and restrict access to anyone who has had contact with a confirmed case of COVID-19.</p>

1h. FACE COVERINGS, FACE SHIELDS, AND CLEAR PLASTIC BARRIERS

OHA/ODE Requirements	Hybrid/Onsite Plan
<ul style="list-style-type: none"> x Face coverings or face shields for all staff, contractors, other service providers, or visitors or volunteers following CDC guidelines for Face Coverings. Individuals may remove their face coverings while working alone in private offices. x Face coverings or face shields for all students in grades Kindergarten and up following CDC guidelines for Face Coverings. x If a student removes a face covering, or demonstrates a need to remove the face covering for a short-period of time: <ul style="list-style-type: none"> • Provide space away from peers while the face covering is removed. In the classroom setting, an example could be a designated chair where a student can sit and take a 15 minute "sensory break;" <ul style="list-style-type: none"> ○ Students should not be left alone or unsupervised; ○ Designated area or chair should be appropriately distanced from other students and of a material that is easily wiped down for disinfection after each use; • Provide additional instructional supports to effectively wear a face covering; • Provide students adequate support to re-engage in safely wearing a face covering; • Students cannot be discriminated against or disciplined for an inability to safely wear a face covering during the school day. x Face masks for school RNs or other medical personnel when providing direct contact care and monitoring of staff/students displaying symptoms. School nurses should also wear appropriate Personal Protective Equipment (PPE) for their role. <ul style="list-style-type: none"> • Additional guidance for nurses and health staff. <p>Protections under the ADA or IDEA</p>	<p>Face coverings are required for all adults who enter the building. MCH is providing face shields and multiple cloth face coverings for all staff members. Staff may also use their own cloth face coverings.</p> <p>All children 3-6 are also required to where face coverings while inside the school building.</p> <p>Parents/Caretakers are required to wear face coverings when dropping off and picking up children.</p> <p>Staff will give grace and courtesy lessons to the children around the usage of face coverings, the reasons for wearing them, and how to effectively take them on and off. If a child refuses to wear a face covering, staff will work with the child to help them feel comfortable wearing a mask.</p> <p>Each classroom will set up a designated space for each child to place their face covering while eating, prior to going outside, or when taking a nap.</p>

<p>x If any student requires an accommodation to meet the requirement for face coverings, districts and schools should limit the student's proximity to students and staff to the extent possible to minimize the possibility of exposure.
